As we prepare for our upcoming listening sessions, we would like help you be aware of the challenges our parishes face. All registered parishioners will be receiving our normal annual report in the mail in the coming days. *Please read that report.*

To help you further understand the challenges we face, on the reverse side of this insert, you will find a summary of our attendance and finance trends from 2018-2024.

While attendance dropped drastically when COVID arrived, the good news is that since we resumed public Masses, the attendance at St. Benedict's has been steady and St. Mary's attendance has increased. Still, we pray that everyone who stopped coming to church will return.

The good news financially is that collections in both parishes, even though fewer people are coming, are slightly higher now than when COVID arrived.

The bad news financially is that our expenses are higher. Why? Inflation. We have done nothing that resulted in increased expenses. It is simply inflation (salaries/utilities/insurance).
